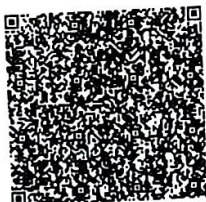

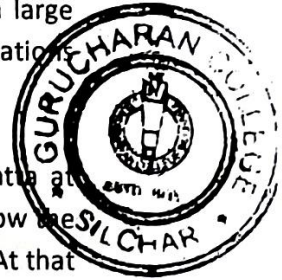
AND

Ambedkar College and Gurucharan College, Silchar are independently referred to as 'party, and collectively as "parties". The parties agree to engage into broad spectrum of joint activities in the fields of promotion of educational programmes, Research Activity, Faculty & Student Exchange, Training programmes and cultural programme etc. This MoU shall be treated as the guidelines on which both parties agree to work together in future. The terms and conditions of this MoU are mentioned in following para

1. BACKGROUND

Ambedkar College, a General Degree College under the Department of Education (Higher), Government of Tripura, is situated at Laldahar, a village of scenic beauty in the bank of the river Manu in Fatikroy under Kumarghat subdivision of the Unakoti district of Tripura, Pin: 799290. The college was established on 26th September 1991. The college offers undergraduate (UG) programs, i.e. Bachelor of Arts (B. A.) Honours (TDPH) and General (TDPG) in several subjects, viz. Bengali, Education, Economics, English, History, Political Science, Philosophy, Sanskrit, and Bachelor of Science (B. Sc.) both General and hons course in Physical Science with Physics, Chemistry, Mathematics and Zoology and B.sc General Course in Botany, Zoology and Human Physiology.

Gurucharan College, established on 15th July, 1935 is recognised as one of the premier institutions in the field of Collegiate education. It has carved out a distinct identity of its own in the field of higher education in the eastern part of India. The well-acclaimed reputation of the college stands not on its vast area of land, buildings constructed on it or on its enrolment strength but on its enriched academic & intellectual legacy built up during the timespan of 87 years of its life at the cost of effort and sacrifices of a batch of dedicated personalities who left no stone unturned to erect this huge edifice of higher education in this Barak Valley. Today, this institution of potential excellence is proud to have a large number of alumni who have established themselves in different professions and vocation of life in India and abroad.



Initially the college was housed in a Bungalow of one Late Promode Chandra Datta at Rongpur on the bank of the river Barak. When the river bank erosion began to swallow the college premises, it was shifted temporarily to the campus of Silchar Normal School. At that time, classes were held in the Morning shift. However, this temporary phase of crisis of accommodation was soon over. Gurucharan College began to receive generous help and assistance from different quarters and ultimately it was able to acquire permanent space in its present state of location. Initially, the college had been affiliated to the Calcutta University. In 1949, the college was affiliated to the Gauhati University. With the establishment of the Assam University (Central) at Silchar, in 1994 Gurucharan College is now affiliated to the Assam University. Today, the college boasts of having a student enrolment of almost 5000 in Arts, Science, and Commerce, BBA (Management) encompassing- 25 departments stream taking into account H.S. and Degree students. Having received the accreditation from NAAC, Bangalore as A grade in 2nd cycle of NAAC along with

the recognition of College with Potential Excellence by UGC, Gurucharan College is making immense contribution to the growth of higher education. 2. PURPOSE & SCOPE

The goal of cooperation will be accomplished in various ways which may include:

- Exchange of Students
- Exchange of faculty
- Exchange of scholarly and pedagogical materials
- Socio-cultural Exchange
- Technical assistance and/or training
- Other cooperative efforts as may be specified later.

3. OUTLINE OF COLLABORATION

Under the aegis of this agreement, the parties shall jointly explore the possibilities of working mainly in the North Eastern part of India. The broad areas of cooperation would include the following: -

- a. Designing viable and feasible roadmap for joint activities;
- b. Taking up studies and action research projects on socioeconomic analysis, livelihood security, market intelligence, value chain and other areas of research in NE region of the country;
- c. Mutual help in promoting placement of the students of both the institutions in the private sector.
- d. Planning and organizing seminar, conference, workshop, training and capacity building programmes in the domains of entrepreneurship, livelihood promotion, new enterprise creation and cluster development and other common area of specialization of both the institutions.

The separate Terms of reference (ToR), deliverables and sharing of the credits including Intellectual property rights will be laid down with mutual consensus at the beginning of the activities.

4. PERFORMANCE STANDARD

The parties shall perform their respective roles and responsibilities under this MoU with highest standards of professional and ethical competence and integrity. Both Parties shall also respect rules, regulations and policies of both institutions.



5. VALIDITY OF MoU

This MoU shall have provision of periodic review of the activities and progress. This MoU shall be valid initially for a period of three years, which can be extended to 2 years subject to recommendation of review committee by mutual agreement. Any cessation of this MoU by either Party shall be notified in writing to the other Party at least 3(three) months in advance in writing.
