


**Memorandum of Understanding (MoU) is executed on this 8th day of September, 2022 at Silchar**

**BY AND BETWEEN**

**Gurucharan College, Silchar** a leading educational institution in the North Eastern region of India, having its campus at College Road, **Silchar**, Cachar-788004, Assam, India represented through Principal, Gurucharan College (which term or expression unless repugnant to the context or meaning thereof shall be deemed to include its successors and permitted assigns), hereinafter referred to as the **"G C College"**, or the **"FIRST PARTY"**.

And

**Niramaya (Charitable Trust & School of Yoga)**, Head Office : Vivekananda Road, lane no: 17, House no-7, Silchar, 788007, Cachar (Assam), hereinafter referred to as the **"Niramaya"**, or the **SECOND PARTY** and represented by its authorized signatory Dr. Ajit Kumar Bhattacharjee (which term or expression unless repugnant to the context or meaning thereof shall be deemed to include its successors and permitted assigns) of the Other Part.

(Gurucharan College, Silchar / 1st Party and Niramaya / 2nd Party, hereinafter are individually referred to as **"Party"** and collectively referred to as **"Parties"**)

**AND WHEREAS** both the Parties come to consensus of putting up joint efforts to provide coaching & guidance in Yoga, promotion of Yoga and career opportunities in Yoga as both the Parties agree by utilizing the premier institution of the First Party for the selected students of 1st Party and with resource support of the 2nd Party.

**NOW, THEREFORE**, in consideration of the mutual promises made in this MOU, the parties hereto agree as follows:

1. That the First Party wants to promote wellness, health awareness through various programs, training & Courses of Yoga and the Second Party is actively

engaged in promoting education, wellness, and health awareness through various courses, training in the field of Yoga.

2. That the Second Party is affiliated to internationally reputed Paramanand Institute of Yoga Sciences & Research (Leading yoga institution Govt. of India. Yoga Alliance, USA & International Association of Yoga Therapists, USA recognised Yoga Institution). Second Party is also affiliated to Mudra Yoga Certification (PrCB of YCB, Ministry of Ayush, Govt of India) & ISO 29993, 9001 Certified. On the basis of these affiliations, the Second Party has been authorised to run, organise & teach different Yoga courses.

3. That the First Party is willing to run Yoga courses jointly with the Second Party. Further the First Party will manage Infrastructure facility & Students enrollment system and the Second Party will be responsible for all kinds of training & assessment process.

4. That the First Party will pay the Second Party 70% of the Tuition fees for the Yoga courses run jointly, whereas the Second Party will retain 20% of the same for the management expenditure. However, in case of professional Yoga training like Government level, Yoga alliance level or other Yoga Training Programmes, the candidates will pay Enrollment Fee & Assessment fee separately.

5. After training & assessment, certificate will be issued jointly by both the Parties. In case of Professional Yoga Examination, the student/ candidate will get the main Certificate from Govt. of India/YA/IAYT.

6. This MOU will be in effect for 3 years from the date of signing by the authorized signatories of both the Parties.

7. For any change / amendment of this MOU, there should be written consent/agreement by both the Parties.

8. That this MOU shall be fully enforceable in India and shall be governed by and construed with the laws of India.



9. That in the event of differences disputes arising between the parties in respect of any matter out of and relating to this Memorandum of Understanding, such dispute difference shall in the first instance, be resolved amicably by mutual consultation within 30 (thirty) days of the reference of dispute by either party

10. That both the parties agree to submit all their disputes arising out of or connection with this MOU to the exclusive jurisdiction of the courts of Assam
